A WORD FROM THE PASTOR

Welcome to our redesigned annual report! In the past, our reports did much "telling", but we have changed our format to be both "show" and "tell". We hope you enjoy the many photos celebrating the past year's ministry. As pastor, one of my leading questions is always "what is the Gospel goal of each of our church services, events, activities, meetings?" We are in a time of recognizing that some of our ministry is flourishing towards our Gospel goals, and some needs updating or rethinking or reinvestment to be effective in the culture and time in which we live.

For example, I spend much time on how our church communicates. We work hard to communicate across a variety of print and digital platforms. I manage the church website and social media while Diane in the office takes care of our print and email communication. We work hard to eliminate as much "insider church language" as we can to make our announcements clear to visitors and newer members. We are working on increasing our level of invitation and visibility.

With the Session, I keep the conversation going about welcome, inclusion, invitation, change, cultural adaptation, and spiritual leadership. I do believe our Elders "get it", and I have experienced willingness in our core membership to recognize that some trial and error is needed to figure out how to continue to bear witness to the love of Christ when there is more than ever out there competing for our time and attention.

Over the past year, it has been a great joy to work with our Worship Committee to bring creativity and new ways of approaching God into worship. On Ash Wednesday, we gathered in Fellowship Hall, to circulate among various prayer stations which provided tactile and visual ways of practicing confession, intercession, reflection on scripture, questioning, and other spiritual contemplations. In the summer, you all cut out fabric fish, which ended up on a set of paraments for the sanctuary which I made to accompany our "Gone Fishin" sermon series. In Advent, you opened doors on our advent calendar revealing spiritual gifts, which I videoed and shared daily online.





"Therefore prepare your minds for action; discipline yourselves; set all your hope on the grace that Jesus Christ will bring you when he is revealed." 1 Peter 1:13 It's been ages since anyone went on a retreat, and our Presbyterian Women were looking for ideas, and so I suggested a retreat, and off they went! Photos in their report! I have also been advising PW on how they might continue to honor their history and the value of their ministry, but find a more sustainable way of proceeding. You will hear about their proposal in our annual meeting.

Our mission giving remains diverse and generous. The Church & Society Committee stewards the budgeted mission giving. In addition, we collect special offerings, including the noisy offering which gives our kids the opportunity to learn about sharing with people in need. The Deacons collect for the food pantry, as well as giving out of their account. Dorcas, Mission Belles and PW all also give to mission both monetarily and with donated items. The Men's Group has chipped in on occasion too. I help individuals both in our congregation and from our community with emergency assistance through the Pastor's Discretionary Fund.

Our church does not exist in a vacuum. I spend about 10 hours per month active in the Presbytery of the Coastlands, currently on the Commission on Ministry and the Grant-making Team. Paving the way for future collaboration, I am in conversation with clergy from 8 other local congregations. There is so much desire and openness to collaboration, and I hope we can take advantage of that in 2024.

May we remain steadfast in faith, hope, prayer, and action as we joyfully follow our Lord Jesus Christ.

FROM THE CLERK OF SESSION

The Session of the Presbyterian Church at Shrewsbury, NJ meets on the third Tuesday of each month. Special meetings may be called at any time if they are considered necessary. The Ten (usually 15) Elders are elected by the congregation in accordance with the Book of Order, are ordained, and serve threeyear terms (ideally) with a limit of six consecutive years. Vacancies are filled as they may occur by special elections. The Pastor serves as Moderator of the Session.

CHRISTIAN EDUCATION

As we reflect on 2023, we are thankful and blessed for another wonderful year for Christian Education! We continued to meet on the 1st and 3rd Sundays this past year. That schedule seemed to work well since the children often have other worthwhile activities that compete for their time on Sunday mornings.

Fortunately, the eleven children who were participating in Sunday School by the end of last year, all continued to attend through 2023. Of course, we would love to have more children join us but without at least a parttime Director of Education to help spearhead a marketing effort (as well as oversee Christian Ed in general), we are limited with time and experience to do more outreach and advertising. We are thrilled that our former DCE Sherri Adler Laberdee has been able to add invaluable support, ideas and knowledge to our efforts. Nevertheless, with Lisa, Libby, John and Sherri working full time and having other commitments, it is a challenge to offer additional programs and opportunities to our

church families. We would also love to be doing activities with our four Junior/Senior Highs but we are stretched thin as it is.

For two consecutive summers, we have missed seeing and hearing the Hope Haitian Choir due to numerous challenges and tragedies that plague Haiti. We continue to pray for their safety and well being and look forward to the time when they can resume their awe-inspiring and uplifting concerts! As we receive information about ways that we can assist them from afar, we will continue to share the information with the congregation.

As many of you know, in the fall of 2022 Pastor Katja charged the Sunday School children with deciding how the Noisy Offering should be used to benefit others. After much discussion and then a vote, the children announced that the goal was to raise \$600 to buy a cow, two piglets, a fishing net and a sewing machine for a family in Africa. At the time that they announced their goal, there was \$241.52 in the Noisy Offering which means another \$358.48 was needed to reach their goal. The congregation was so generous and supportive that in May 2023, there was \$942.52 in the Noisy Offering. Not only was the goal met but the Noisy Offering for this year started with a balance of \$342.52! As of October 2023, the amount in the Noisy Offering was \$462.79. The children will be starting the process soon of deciding how this year's Noisy Offering can benefit others. Thank you all for supporting the children and their Mission Projects



This fall our 4th annual Trunk or Treat proved to be even more successful than last year with more children treating, more cars trunking, new games for playing and more church members spectating! Thank you to the volunteers who helped behind the scenes especially with cleaning up! We also continue to be blessed and thankful for all the work that Cari Suarez does to help, support and keep us organized on an ongoing basis!

Despite some challenges in preparing and rehearsing for the annual Christmas pageant including Libby, Sherri and Lisa each battling health issues and a full cast rehearsal not an option with children having other commitments, "A Superhero Christmas" was still a hit! With Libby's quick thinking and the kids' ability to easily roll with modifications, even last minute technical issues did not put a damper on the production. As they say, the show must go on! We hope everyone enjoyed a modern twist to an age old story as much as we did!

As we enter 2024, we realize that we have not had a Director of Christian Education since March of 2020. While the CE Committee is willing to continue to do our best to provide an engaging Sunday School experience as well as additional events and activities, we know there is so much more that can be done to further enrich CE. Although we had planned to push for a DCE search last year, it never really got off the ground. Over the past two years, we have also lost some of our long time committee members for a variety of reasons. As always, we would like to extend a tremendous "THANK YOU" to everyone in the congregation and Session for their unwavering support of Christian Education. CHURCH & SOCIETY

The Church and Society Committee has continued to address the needs of both our local and global communities. We started the year with a Lenten Project supporting Ocean's Harbor House in Toms River. This is a shelter for youth age 10 through High School. We collected 50 reusable water bottles, 9 large bags of paper products, 10 large bags of toiletries, 6 large bags of cleaning projects and 20 umbrellas. The Jean Kelly Calendar Collection, we collected and delivered over 110 calendars for our troops. We held 2 Blood Drives, one in February and one in October along with IMA. For our Christmas Advent Project we sold Christmas socks, both child and adult, along with homemade prayer pebbles at the Christmas Bazaar. The monies collected were sent to the Hoboken Homeless Shelter. We held a 5 Wishes Program at our Church. We supported MOSAIC, Ocean Harbor House, Trevor Project, Women's Hospitality Network in Asbury Park, No Limits Cafe and the Pastor's Discretionary Fund. We sent monies to The Fresh Air Fund, Johnsonburg Camp and American Camp Association for children to be able to attend during the summer. We also supported the friends of Pine Ridge Reservation Lakota Families, the Wheelchair Foundation and Easter Seals. We helped support a local church family who is going through difficult times.

We continue to support the Deacons with the Eatontown Food Coop. The monies made at the corn hole game on the front lawn at the Strawberry Festival went to the Food Co-op. Our global projects included our ongoing sponsorship of Austin Yuriel Garcia Gerardo. Our continued support and participation in the Crop Hunger Walk. We supported the Ukraine with monetary donations to the IRC for aid in heating. We helped in their recovery in both Rolling Fork, Mississippi and Maui through Presbyterian Disaster Assistance. We assisted in aid to Israel through the Magen David Adam Charity and to Gaza through the UN World Food Program.

Our committee organizes the Presbyterian Church Special Offerings including Peacemaking and Joy Offering. Our 1/4 of the Peacemaking Offering was sent to the Carter Center in memory of Roslynn Carter. We support One Great Hour of Sharing which benefits Church World Service.

Our committee designates the mission money allocated in the church budget. We take this task very seriously. We disperse these funds to meet international, national and local needs. We do our Mission Giving quarterly. 1Q was Cold, 2Q Children and Summer Camps, 3Q Disabilities and 4Q LBGTQ+ Awareness and International Disasters. We have been sharing our mission giving in the Towne Crier.

This year continued to be met with challenges but our committee did our best to continue to support those in need.

PLANNING & ADMINISTRATION

BY DAVID APY. CHAIR

It was a good year financially even though we adopted a 2023 budget with a \$8,486 deficit. We finished the year with an operating surplus of \$16,943.

On the negative side, the amount pledged in 2023 was not fulfilled by \$11,274. However, overall income was \$3,176 more than budgeted, mostly due to increased income from the use of the Church House, unexpected increased interest on savings due to the increase in interest rates,

and non-stewardship donations.

On the expense side in explaining the surplus, the 2023 budget included \$11,125 for a Director of Christian Education, which was not spent despite best efforts to fill the position; and other line items in the aggregate came in below the anticipated amounts due to a number of diverse reasons.

Overall, the above factors account for the operating surplus of \$16,943.

Requests for the 2024 budget were solicited from all committees, the office, and other programs. Pledges are up from \$212,040 in 2023 to \$217,864 in 2024, which is very encouraging. However, the total number of Church members who have pledged has continued its trend of decreasing each year. The 2024 budget has not been finalized as of the time of this submission.



As a statement of God's faith acting through each of us, if you have not pledged for 2024, please do so since it is not too late: Pledging is imperative for responsible planning for the operation and finances of the Church. And, as a spiritual discipline, it is critical to the continued strength and vitality of our Church community.

STEWARDSHIP

In May, we gave a Minute for Mission to encourage members to give their Per Capita (\$40 per member) to support our Presbytery and all other levels of the Presbyterian Church, which is foundational to our denominational relationships. As has been the pattern, not all members paid their Per Capita even though PCAS pays the full amount based on the number of PCAS members. On Pentecost Sunday in June, we dedicated all our Per Capita giving.

For our stewardship campaign this fall, we used the theme "Let Us Build a House" based on the well-known song "All Are Welcome" by Marty Haugen. During Sunday worship, we had three members, Barry Semple, Kurt Kaboth and Lisa Barnes share why our church matters to them. We thank each for their faithful sharing.

We had a successful campaign. By the end of December, we received 60 pledges for 2024 totaling \$217,864, which represents a 2% increase compared to the 2023 pledges. However, the number of pledging units was down by 2.

Thanks to Pastor Katja for her help in planning the fall campaign, to Diane Suarez for producing the pledge cards and letters, to Evan MacKay for stuffing the mailing envelopes, and to Ken Gibbons for tracking and summarizing the pledge results.

PRESBYTERIAN WOMEN

Presbyterian Women was created more than 200 years ago when women had no role outside the home. In 1872 the General Assembly of the United Presbyterian Church in North America (UPCNA) asked women members to raise money to support women missionaries in the field. It took more than 26 years for PCUS to get permission to set up a national women's organization.

PW includes all women of the church and our purpose is to nurture our faith, support the mission of the church, work for peace and justice, and to build an inclusive, caring community that strengthens the church and witnesses to the promise of God's kingdom. Our purpose is still valid, but the situation has changed significantly in 200 years. Women now have much more of a voice in the church. Most working-age women work outside the home and have little free time. Due to less work force and more voice in the church as a whole, we are in the process of restructuring PW at PCAS.

This year we were able to have an almost normal year of activities. PW contributed \$2500 to the church, gave \$500 to PW of Monmouth, and donated \$100 to each of 10 charities including the Joy Offering. We also helped Mission Belles with 2 funeral Receptions, one of them our beloved Vice Moderator, Bonnie Tortora.

The annual Women's Service was held on April 23 with Testimonials by Chris Kustka, Sue Starke, Bonnie Tortora and Nancy Vodhanel on "What PW Has Meant to Me". We thank Bonnie Tortora and Kay Healy-Wedsworth for all their time and effort putting together this meaningful worship service for all!

In June we were able to have the Strawberry Festival with Nancy Vodhanel as chairperson. Trash and Treasure was in Fellowship Hall and was our main fundraiser for the event. Everything went well with a wonderful lunch by the Deacons and strawberry desserts made by Dorcas.



Thanks to a very generous and unexpected gift to PW we were able to invite any members of PW to go to a Women's Retreat at Johnsonburg at the end of October. Thirteen members went including Pastor Katja. The weather was gorgeous – unseasonably warm- and the program was everything we could have asked for.

We held our annual Christmas Bazaar on Dec. 2. Most of our booths were included: Christmas Treasures including Crafts and Toys, Greens Decorations, Baked Goods, Soups and Books as well as the Deacon's Lunch were all in Fellowship Hall. Jewelry was in the Terrace Room; Poinsettias, Santa Photos in the foyer. The spirit of Christmas was definitely with us and we brought in over \$3000.

This year PW supported the Birthday Offering and Least Coin Offerings. We thank Diane Suarez for taking care of mission giving. Sue Starke sent cards to many people throughout the year letting them know they were not forgotten. A big thank you goes to Kay Healy -Wedsworth for always having a heartfelt prayer, to Linda Talerico for keeping the kitchen sparkling and organized and to Heather for all her financial help and for lending a hand any time she could.

I wish to thank all the dedicated Board Members for their hard work and support as well as everyone who contributed in 2023. PW is in the process of working on ideas to continue our mission work and meet the needs of the women of the church as our congregation changes. Best wishes to the new PW restructured board in 2024.

In compliance with section G-10.0401(d) of the Book of Order, a financial review was conducted for the year 2022 as pertains to the various accounts within the church family.

The Financial Review Committee of the Presbyterian Church at Shrewsbury, consisting of Debi Coccaro, and Bill Schanck, examined the financial books and records associated with the Church's general operations as well as those of specific committees which maintain separate financial accounts for management of their associated income and expenses. These groups and accounts included:

General Church Checking, Savings and Credit Card Presbyterian Women Mission Belles Men's Group Endowment Fund Investment Account Cemetery Trust Fund and Operations

Bank statements, checkbooks, broker statements, invoices / expense request documentation, journals and receipts indicating payment were all included in the review.

PRESBYTERIAN WOMEN Future Ministry Reccomendation

j)Sending gift cards for meals for those in need (i.e. DoorDash, Grubhub, Uber Eats)

k)Other needs as may arise

Presbyterian Women will no longer be responsible for:

a)The Christmas Bazaar

b)The Strawberry Festival

c)Sunshine ministry

d)The maintenance of the kitchens in The Social Room and the Church House

- e)The reception after the Thanksgiving Eve joint worship service with Monmouth Reform Temple, when the service is held at PCAS
- f)Providing flowers for the reception following the Thanksgiving Eve joint worship service when it is held at the Temple
- g)Receptions following funerals and memorial services

Please note it will not be the responsibility of the new Women's Group to decide if any of these items are important enough to continue or to solicit volunteers.

Our hope is that there will be people who will have a calling for these important ministries and fellowship opportunities and will volunteer so they can continue in some form.
